Interra Online banking services and Interra Bill Pay (accessed through Interra Online), are free benefits of Interra Credit Union membership, but you must register in order to use them. You may register for Interra Online independently from Interra Bill Pay. However, Interra Bill Pay services may only be accessed through the Interra Online banking system, therefore requiring that you be registered for both.
