## Multi-Account Access Authorization Examples

The multi-account access form allows authorized members to access multiple member numbers in online banking with a single username. Refer to examples below for sample scenarios. Please contact the credit union if you need further assistance.

**SAMPLE 1:** A married couple wants access to each others' accounts. His accounts are 111111 and 222222; her account is 333333. Currently neither is a joint owner on the other's account. However, they would still like to be able to access all shares and make transfers\* on all accounts regardless of which account they are signed into.

**SAMPLE 2:** A mother with account 111111 would like access to her children's accounts that she is a joint owner on (222222 and 333333). She also needs to be able to make loan payments on her father's account, which she is not on (444444, loan ID 69). The mother does not want her children, nor her father, to have any access to her account, nor does her father want her be able to see his other account balances or make withdrawals/advances on the line of credit.
