## **FACTS**

# WHAT DOES INTERRA CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- account balances and payment history
- credit history and credit scores

When you are *no longer* our member, we continue to share your information as described in this notice.

#### How?

All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Interra chooses to share; and whether you can limit this sharing.

How does Interra protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  In addition, we use "cookies" for security purposes with our online transactions and web based applications and communications.	
How does Interra collect my personal information?	We collect your personal information, for example, when you

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
	Our affiliates include Members Financial Management Center, Inc.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
	Interra does not share with nonaffiliates so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
